l agree to the weekly rate of \$300 per week per child to be paid in advance prior to the beginning of the applicable service week. Weekly fees are due the Friday before the applicable week.
I will be utilizing PFCC(voucher) or CPP funds for care.
A late fee of \$25.00 per day will be assessed for late payments. EXCESSIVE LATE PAYMENTS WILL RESULT IN YOUR CHILD(REN)'S DISENROLLMENT FROM THE PROGRAM UNTIL ALL APPLICABLE PAYMENTS AND FEES ARE PAID IN FULL.*
Please note that full-time care will not exceed nine (9) hours per day. Part-time care will not exceed four (4) hours per day. For unscheduled
