



Your Learning Treehouse, LLC FULL-TIME CONTRACT

This agreement is made by and between Kerrence S. Rose, Licensed Child Care Provider, and _____, the Parent(s)/Guardian(s) of _____. The following has been agreed upon between the two parties, beginning _____. Our arrival time will be _____, and pick up time will be no later than _____. Any added time before or after these times will be discussed and agreed upon beforehand, and will be subject to additional fees.

A registration fee of \$25.00 per child or \$50.00 per family is due upon enrollment and an enrollment reservation fee equal to $\frac{1}{2}$ of the family's monthly fees is due upon enrollment to Your Learning Treehouse, LLC. The fee holds your child(ren)'s spot only for a particular month. The fees listed are non-refundable.

_____ I agree to the weekly rate of **\$300 per week per child to be paid** in advance prior to the beginning of the applicable service week. Weekly fees are due the Friday before the applicable week.

_____ I will be utilizing PFCC(voucher) or CPP funds for care.

A late fee of \$25.00 per day will be assessed for late payments. EXCESSIVE LATE PAYMENTS WILL RESULT IN YOUR CHILD(REN)'S DISENROLLMENT FROM THE PROGRAM UNTIL ALL APPLICABLE PAYMENTS AND FEES ARE PAID IN FULL.*

Please note that full-time care will not exceed nine (9) hours per day. Part-time care will not exceed four (4) hours per day. **For unscheduled late pick-ups, fees will be assessed in the amount of \$5.00 per minute per child.** The late fee is payable by cash, Zelle, or ApplePay at the time of the late pickup. THERE ARE NO EXCEPTIONS.

NO ADJUSTMENT IN FEES WILL BE MADE FOR ANY REASON. ALL FEES ARE TO BE PAID REGARDLESS OF ATTENDANCE OR PROGRAM CLOSURE. THERE ARE NO EXCEPTIONS.

This agreement shall be in effect until which time parent(s)/guardian(s) or provider gives notice of termination in accordance with the Parent Handbook policy, or all parties mutually assent to a new written agreement replacing this one.

I understand that I must follow the termination policy as stated in the Parent Handbook.*



By signing this contract, all parties confirm that they have read, understand, and agree to the full contents of the Parent Handbook, including but not limited to the financial responsibility information for the preschool/childcare provided. Parent(s)/guardian(s) understand that violating these policies may result in termination from the program.
